Dear Property Owner:

The Franklin County Department of Sanitary Engineering (FCSE) is pleased to share that construction to provide sewer systems in the Mon-E-Bak and Brown Road East areas is nearly complete, and the home to sewer connection process can now begin. **The deadline to connect is Dec. 20, 2019**.

Financial assistance is available to those who meet **all** program requirements. **The deadline to file an application is Feb. 16, 2018.** Information regarding program eligibility, an application and the connection process are enclosed. We encourage you to complete and mail or fax the application right away. We also invite you to attend one of our public meetings to learn more about the process and to get answers to questions regarding financial assistance and connection requirements.
